


WildAid's Elephant/Rhino conservation program educates consumers and works to reduce the demand for ivory products worldwide. In 2012, through a partnership with Yao Ming and Save the Elephants, WildAid filmed and photographed the former NBA superstar's fact-finding visit to Africa. The initiative produced content that continues to be seen throughout the world with a focused presence in China, the globe's number one consumer of ivory products. WildAid will now produce a feature length documentary featuring Yao Ming, using the captured content to broaden the reach of our mission to protect elephants and rhinos through heightened awareness of the underlying consumption issues. The Elephant & Rhino campaigns build upon our successful Shark model, with the message "When the Buying Stops, the Killing Can Too."

WildAid's Galapagos program works with the Galapagos National Park Service (GNPS) and local communities to build comprehensive protection for the Galapagos Marine Reserve. Since 1998, WildAid's work has strengthened the surveillance and interdiction capacity of the GNPS by introducing cutting-edge, electronic monitoring systems to intercept illegal fishers. Our program provides ongoing technical assistance, trainings, additional mechanics and lawyers, investments in VMS, AIS & radars, spare parts, development of SOPs, and educating Ministers among other activities. In cooperation with local Authorities, WildAid developed quarantine mechanisms to prevent the introduction of invasive species, and strengthen control aspects in the current shipping system: mainland/island port facilities, qualifications of personnel, vessel standards and cargo handling; all key links in the quarantine chain.

WildAid's China-Sharks program leverages donor contributions to produce content for an unrivaled network of pro-bono media partners. In 2012, the market value of pro-bono media in China exceeded \$132 million. Central to WildAid's delivery is the ability to target decision-makers and opinion-formers including government officials, media organizations, leading executives and wealthy urban consumers to achieve a dramatic and permanent shift in the global demand for illegal wildlife products. The resulting campaigns have produced tremendous results. According to the South China Morning Post, the Census and Statistics Department of Hong Kong reported that shark fin imports have reduced from 10,292 tons to 3,087 tons from 2011 to November 2012; over a 70% decline. The program also promotes new regulations for protection of wildlife and greater international cooperation for improved enforcement.

All donations and grants made to third parties, such as the Galapagos National Park Service or a Fishing Cooperative, are supported by a contract between the institution and WildAid. The contract clearly states the donor source and all funds disbursed or equipment donated is to be employed solely according to the objectives stipulated in the contract.

With respect to grants, the contract stipulates that separate accounting must be carried out including the creation of a file of deposits, receipts, contracts etc to support all expenses incurred. All receipts and invoices must be legal and clearly indicate the beneficiary, concept of payment and date. In addition, the institution agrees that their checking account and accounting is subject to an external audit or other measures of control defined by WildAid. Normally, the WildAid accountant reviews all expenses incurred by the partner institution and pays a visit to their offices to physically review documents and products resulting from the grant. With respect to equipment donations, periodic visits are made to the project site to verify the condition of the equipment donated.

WildAid's "5 To Do Today" Climate program is an initiative focused on improving our planet's environment through encouraging individual action and generating political will. Goals such as improving air quality, reducing natural resource consumption, supporting public transportation, and using recycled products not only helps foster sustainable lifestyles but also helps bolster healthy ecosystems and habitats for wildlife. Leveraging our current network of celebrities, media partners, and distribution channels in China and around the world, the "5 To Do Today" program will encourage each person to choose 5 simple things to do every day to reduce his/her individual environmental footprint. In addition, the "5 To Do Today" program will work with governments to promote relevant policy change and with businesses, foundations, and NGOs to create unique public awareness campaigns for environmental knowledge. As the program grows, WildAid hopes to connect the East and the West in the sharing of ideas to change our world, one person at a time.

In Indonesia, WildAid focuses on strengthening Marine Protected Area (MPA) enforcement in Southern Raja Ampat, West Papua. WildAid works with the Coral Reef Alliance and the Misool Eco Resort (MER) to operate a highly effective conservation organization called Baseftin to patrol two No-Take-Zones (NTZs) totaling 224 square nautical miles. The No-Take Zones prohibits removal of anything in the sea including fish, shark fin, sea turtles, shells, and sea turtle eggs yet respects traditional "sasi" zones allowing the targeting of *Trochus niloticus* and *Turbo marmoratus* for two weeks every two years. WildAid assisted in the procurement of two patrol vessels, construction of strategic vigilance posts, the provision of surveillance equipment, and the design of a VHF marine radio network. Underpinning all tourism and enforcement is MER's commitment to community outreach and ensuring local benefits via

employment at the resort, hiring of local patrol rangers, monthly community outreach activities, the construction of a kindergarten in Fafanlap, and a community trade center at Usaha Jaya, among other initiatives.

WildAid's shark conservation program seeks to reduce the threats to sharks caused by over-fishing and over-consumption of shark products and wasteful practices such as finning and needless bycatch. WildAid aims to improve data-collection and research, to advocate protection for individual species under international agreements and conventions, and to support marine reserves and other key areas where sharks are protected. Since 2000, WildAid's shark program has successfully elevated the international profile of sharks and has highlighted the importance of conserving sharks globally. The resulting campaigns have produced tremendous results, contributing greatly to a decline in fin consumption in China. According to the South China Morning Post, the Census and Statistics Department of Hong Kong reported that shark fin imports have reduced from 10,292 tons to 3,087 tons from 2011 to November 2012; over a 70% decline.

As many Marine Protected Areas (MPAs) are relatively new and share similar challenges, WildAid organized a Global MPA Enforcement Conference to assist countries in prioritizing enforcement initiatives to bolster their capacity and avoid a costly learning curve. Based on inquiries made with practitioners, a clear need for a comprehensive law enforcement conference existed as many governments, NGOs, and donors currently implement substandard programs. These programs are often the result of a lack of knowledge with respect to best practices and the benefits of cost-saving technologies, or because the focus has been on only one component or aspect of the law enforcement chain. WildAid went to great lengths to ensure that a

diverse sample of MPAs were represented with differing complexities, resource levels, sizes, and management models. We targeted individuals from varying disciplines to enrich this experience: fishery enforcement officials, Naval officers, scientists, lawyers, academics, technology firms, NGOs and foundation officers. Several conference highlights included:

- WildAid surpassed our initial conference attendance goal of 100 with the total registration of 192 attendees from 36 countries.
- Given generous foundation and corporate sponsorship, WildAid provided either full or partial scholarships to 84 attendees.
- We dedicated an entire day to explore the variety of technologies used in the surveillance and enforcement of MPAs. Technologies explored included: Satellite Vessel Monitoring Systems (SVMS), Automatic Identification Systems (AIS), radars, video cameras, Unmanned Aerial Vehicles (UAVs), in addition to open source software platforms.

In India, WildAid has built a network of government officials, celebrities, media partners, and wildlife advocates to assist in spreading our message. The program highlights the importance of maintaining habitats and migration corridors for wild animals while respecting the forest fringe communities surrounding the reserves.

WildAid works in Corbett National Park, India's oldest national park and home to one of the richest assemblages of large mammals. WildAid's current priorities are to purchase and equip rapid response units, to ensure safe migration, and to work with surrounding communities to encourage stewardship.
